Sales Composition by Item



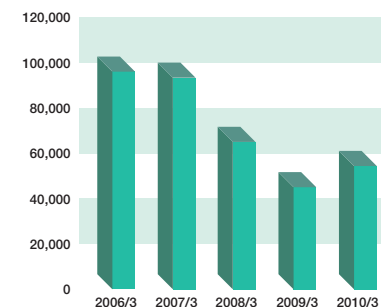

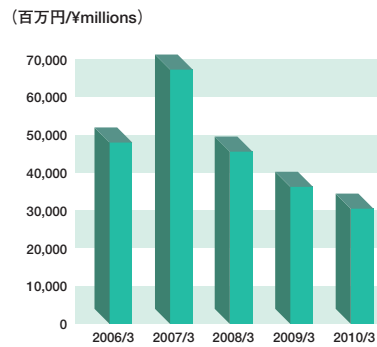
地域別の売上高構成比  
Sales Composition by Area



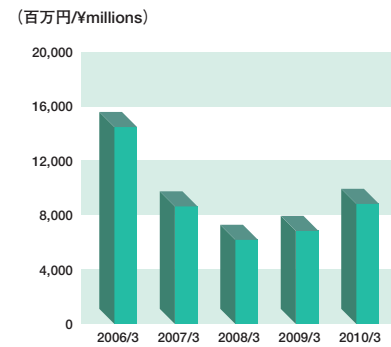

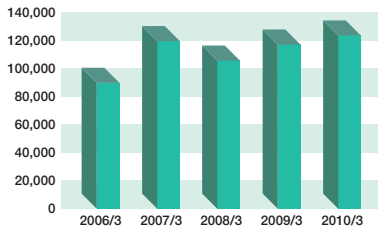

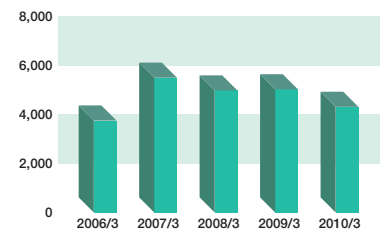

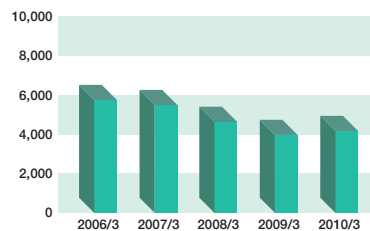

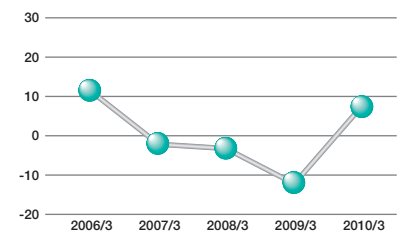
1株当たり当期純利益
